



COVID-19 Guidance for Property Owners

Dear Chautauqua Institution Property Owners and Overnight Guests:

To support a healthy and safe environment for all, this resource is provided to inform you of Chautauqua Institution's actions and recommendations during the COVID-19 pandemic. We thank you for joining us in following all recommended protocols and procedures to keep you, our on-grounds community, and the greater Chautauqua region safe and healthy.

- At this time and until further notice, all Chautauqua Institution offices are closed to the public, per "New York State on PAUSE" regulations.
- Administrative staff are working from home and are available 8:30 a.m. to 4:30 p.m. Monday to Friday via email and phone (visit staff.chq.org for a directory and contact information).
- Chautauqua Institution Police, gate staff, and a limited number of Building and Grounds staff are reporting to work and observing social distancing, workplace sanitizing and personal hygiene protocols.
- The Afterwords Café is open for take-out and delivery of prepared foods and groceries (716-357-5772).
- The Chautauqua Golf Club is open 10 a.m. to 4 p.m. daily as weather permits, following all PGA- and CDC-recommended precautions and protocols. Greens fees and cart rentals can be paid for via credit card by calling 716-357-6211.
- The Chautauqua Post Office is open for business on its regular schedule.
- All traffic is being directed to the Main Gate, which is staffed 24/7 at this time.
- Chautauqua Institution property owners are required to follow all "New York State on PAUSE" regulations.
- Be aware that nonessential construction was recently banned as part of the COVID-19 response in New York State. If you are or were planning construction work on your home, please ensure you and your contractor(s) are in compliance with this policy.

Self-Isolation: If you are returning to your Chautauqua region home while "New York State on PAUSE" regulations are in place, whether or not you are coming from a region or community where there have been confirmed incidents of COVID-19, we recommend isolating yourself in and near your Chautauqua Institution home for 14 days after arrival.

- Bag and String Wine Merchants accepts phone and online orders and offers delivery (bagandstringwine.com).
- Afterwords Café offers on-grounds take-out and delivery of prepared foods as well as grocery delivery service daily, 9 a.m. to 6 p.m. (credit card purchases only – call 716-357-5772).
- Lighthouse Grocery in Mayville offers curbside pick-up daily (pay by credit card over the phone). Delivery is available Monday, Wednesday and Friday (716-753-2829).
- Mayville Tops offers curbside pick-up and delivery through the third-party InstaCart service (topsmarkets.com).
